General Rental Information

Important documents

The lessee and the driver must be in possession of a full, valid driver's license for at least one year and present it together with an identity card or passport while receiving delivery of the vehicle. Furthermore, the following conditions apply depending on the issuing country of the driving licence.

The driver's license must be valid and issued by:

- member country of EU/EEC;

participant of the 1968 Vienna Convention on Road Traffic - acceptable without additional documentation if in Roman script, otherwise an International Driving Permit is mandatory;
participant of the 1949 Geneva Convention on Road Traffic - International Driving Permit is mandatory.

The International Driving Permit alone is not acceptable unless it is accompanied by a valid national driver's license.

Participants of the 1968 Vienna Convention on Road Traffic: Albania, Armenia, Azerbaijan, Bahamas, Bahrain, Belarus, Bosnia and Herzegovina, Brazil, Central African Republic, Costa Rica, Cuba, Democratic Republic of Congo, North Macedonia, Georgia, Guyana, Indonesia, Iran, Israel, Ivory Coast, Kazakhstan, Kenya, Kuwait, Kyrgyzstan, Liberia, Mexico, Monaco, Moldova, Mongolia, Montenegro, Morocco, Niger, Pakistan, Peru, Philippines, Russia, San Marino, Senegal, Serbia, Seychelles, South Africa, Tajikistan, Tunisia, Turkmenistan, Ukraine, United Arab Emirates, Uruguay, Uzbekistan, and Zimbabwe.

Age Restrictions

Certain regulations apply related to minimum age and possession of driver's license which can be found during the booking process depending on the booked vehicle. Basically, the minimum age for every driver is 19 years (having held the driving license for at least 1 year). A deviation from the minimum age is possible depending on the vehicle.

In Estonia, the following rules apply for the minimum age and possession of a driver's license:

Tariff information

All credit cards and debit cards with credit card functions from internationally recognized credit card companies - such as American Express, Mastercard, Visa, Diners Club, Discovery, JCB are acceptable as payment methods. We do not accept any prepaid credit cards and debit cards (Visa Electron).

Sixt also accepts AirPlus as payment.

The payment method must have been issued in the name of the driver. This must be presented at the time of vehicle pick-up and be valid at this time. The renter must be the owner of the indicated creditcard.

The authorised driver details and method of payment will be confirmed at reservation stage and cannot be amended. All extra costs that occur during the car rental will be charged to this credit card.

Sixt CarExpress Servicecard is only accepted in combination with a valid Credit Card.

Please note that the credit card has to be valid at least 3 months after the estimated end of the rental.

Please note, that payments with credit card require the PIN of the credit card.

An advance charge approval is obtained for the chosen credit card as a security. The exact deposit is determined on collection since the amount is dependent on the vehicle.

Special rental information when booking Prepaid rates Prepaid tariff - Pay now

When booking at a prepaid rate, the payment will be charged along with the total rental price (incl. booked extras and charges) prior to the rental. The driver and mode of payment shall be finalised at the time of reservation and cannot be changed. A refund shall not be issued for non-collection, vehicle being collected late or returned early.

An advance charge approval is obtained for the chosen means of payment as a security. The exact deposit is determined on collection since the amount is dependent on the vehicle.

Changing booking

A booking can be changed up to 48 hours before the start of the rental (on availability) in return for an alteration charge of 20.00 EUR. Any payment already made towards the rental will not be refunded; nor shall any differential amount be refunded if this alteration leads to a lesser rental cost.

Cancellation

A booking can be cancelled before the start of the rental. In the event of cancellation or not collecting the vehicle, the payment already made towards the rental will be paid back subject to a cancellation charge. The cancellation charge shall be the amount of the rental charge (including any extras and charges) for a maximum of 3 rental days. No-show

In the event that the booked vehicle is not collected or not collected at the agreed time, the rental charge already paid shall be withheld in full.

Protection conditions

Third Party Insurance (TI)

Protection coverage for the vehicle includes Third Party Liability with a maximum cover of 1,000,000 EUR for personal injuries and material damages. (Maximum cover for personal injuries is 5.000.000 EUR per injured person per insured event. (Protection coverage is limited to Europe only)).

Excluded from the protection is the use of the vehicle for the transport of dangerous goods. All protection as part of the rental contract will become void, in particular, if an unauthorized driver has used the vehicle or if the driver of the vehicle does not possess the required driver's license at the time of the event giving rise to claim.

Excluded from the protection is driving the vehicle in prohibited areas set by official order or driving the vehicle in off-road terrains.

Loss Damage Waiver (LDW)

Loss Damage Waiver removes the drivers responsibility to a part of the vehicle in case of damage or theft.

If LDW is accepted, customer is only responsible for the following amounts: 850.00 EUR (A, B)

Excluded from the coverage are damages on tyres and windscreen.

If LDW is not accepted the customer will be held liable for the full value of the car.

Top Cover LDW

If LDW is already included in the rates, the renter can choose Top Cover LDW to reduce/eliminate the Non-Waiverable Responsibility.

If Top Cover LDW is accepted, customer is only responsible for the following amounts: 425.00 EUR (A, B)

Excluded from the coverage are damages on tyres and windscreen.

Super Top Cover LDW

If LDW is already included in the rates, the renter can choose Super Top Cover LDW to reduce/eliminate the Non-Waiverable Responsibility.

If Super Top Cover LDW is accepted, customer is only responsible for the following amounts: 0.00 EUR.

Excluded from the coverage are damages on tyres and windscreen.

Tyre and Windscreen Protection (TG)

The tire and glass coverage provides protection for damages on tires, windscreen, side windows and the rear window with a deductible of EUR 0.00.

If the protection is not accepted, the customer will be held liable for the full extent of the damage.

Roadside Assistance

The Roadside Assistance is your extended breakdown protection during your rental and protects you at Baltic states (Latvia, Lithuania and Estonia) against high service and repair costs for the following incidents caused by you:

Shutdown of vehicle alarm, locking the key in the vehicle, start-up assistance in the event of a flat battery, breaking caused by lack of fuel (fuel price not included), damaged tyre change or repair (tyre price not included, subject to Tyre and Windscreen Coverage Protection), getting stuck.

All services may only be ordered by a direct claim with Sixt 24-hour Roadside Assistance. They shall also determine the type and extent of service required to ensure the renter stays mobile. If any damage to the rental vehicle occurs which is not covered by Sixt within the scope of the Roadside Protection, the renter is liable for such damage.

Cross Border Rentals & Territorial Restrictions

Cross Border Rentals are with charge and on request only. Please contact the local rental station.

The vehicle selection can restrict travel to certain countries. For a description of these restrictions on admission, the countries are divided into three zones.

Border Crossings into Zone 1 are free of charge and allowed without additional approval by Sixt.

Border Crossings into Zones 2,3 and 4 are subject to charges, which must be requested via rent@sixt.ee.

Border Crossings to Kaliningrad, Russia, Belarus and Ukraine are strictly forbidden. Zone 1: Estonia, Lithuania, Latvia: free of charge and no additional approval necessary.

Zone 2: Zone 1 and the territories of Finland and Sweden.

Zone 3: Zones 1, 2 and the territories of Andorra, Austria, Belgium, Bulgaria, Bosnia and Herzegovina, Czech Republic, Denmark, France, Greece, Croatia, Italy, Liechtenstein, Luxembourg, North Macedonia, Monaco, Montenegro, Norway, Netherlands, Poland, Portugal, Romania, San Marino, Serbia, Slovakia, Slovenia, Spain, Switzerland, Hungary, Germany, Vatican territories.

Zone 4: Zones 1, 2, 3 and the territories of Great Britain and Ireland.

If the vehicle is used outside the Agreement territory, Sixt shall be entitled to immediately terminate the Agreement without any sanctions on behalf of the Renter. Terms and conditions of the Agreement regarding personal liability, insurance, technical assistance, damage prevention, and/or replacement vehicle shall not apply if the vehicle is used outside the territories specified in the Agreement and/or insurance policy.

Renter shall certify that he has been warned that in such case an extra charge for vehicle insurance, technical assistance, damage prevention, and/or replacement vehicle will apply. In case of offence against Cross Border & Territorial Restrictions all protections lose their

validity.

Bluetooth

Bluetooth is available subject to a fee, in the amount of 4.00 EUR/day, 40.00 EUR per month. **Winter equipment**

Winter tires and ski box are available subject to a fee, under request at least 2 weeks in advance.

During the period from 1st of December until 1st of April snow tyres are fitted for all car groups **Vehicle refueling**

All vehicles are supplied with a full tank of fuel and should be refilled prior to return to Sixt, otherwise a special tariff for used fuel will be charged in addition to a refuelling fee in the amount of 3.00 EUR per litre.

If desired, the vehicle will be refuled according to currently available conditions after returning it to the station.

Alternatively, you may purchase a tankful of fuel at the time of rental at a price that is competitive with local fuel stations and return the tank empty. No refunds will be given for unused fuel.

Delivery and collection

Deliveries and collections are available at the local rental station subject to a fee.

Other Fees and Taxes

Premium Location Fee

A premium location fee occurs for rentals at airport and train stations, in the amount of 24.00 EUR per rental.

Out Of Hours

Out of opening hours service is available at selected stations. In this case, an additional charge in the amount of up to 40.00-80.00 EUR applies for the provision of the service.

Administration Fee For Fines

The renter is liable for payment of all traffic/parking fines occuring during the rental.

The renter of the vehicle is also liable for the administration fee if the vehicle has become a subject to a traffic/parking violation or a damage during the rental period (prices available at the branch).

Smell-Removal-Fee

All Estonian Sixt cars are non-smoking cars. If a car should need additional cleaning/smellremoval caused by smoking or from excessive dirt, a fee for special cleaning will be added to the invoice.

When returning the vehicle, Renter shall not leave any bulky or toxic garbage inside the vehicle (e.g. packaging).

All rates include tax/VAT (if incurred). For corporate customers with individual agreements alternative prices and regulations can apply.
